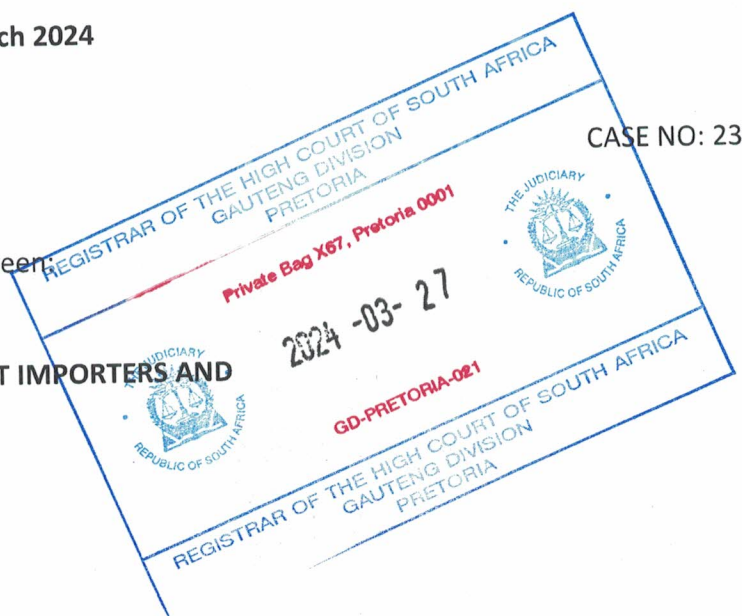

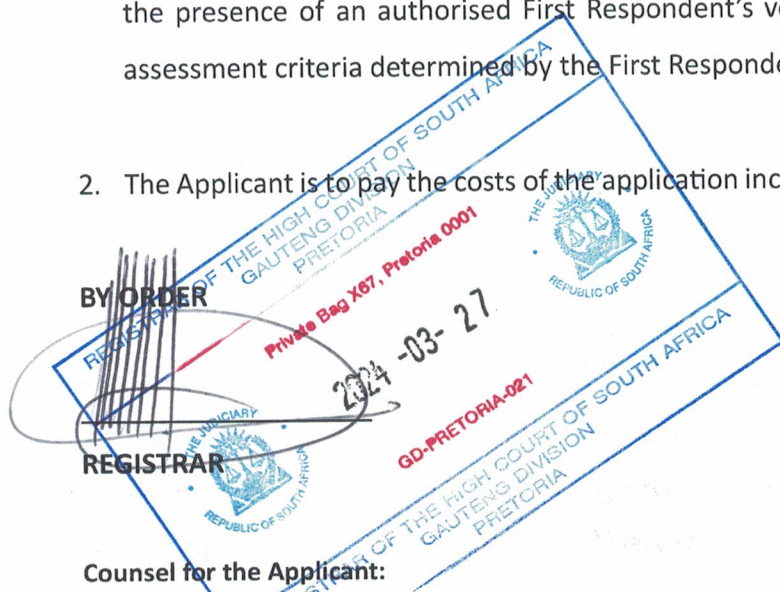

IT IS ORDERED THAT:

1. The First Respondent, when issuing removal permits for the removal of consignments of imported meat or meat products from ports of entry, will only issue removal permits with a condition to the effect that the veterinary seals on consignments may only be broken in the presence of an authorised First Respondent's veterinary inspector, based on a risk assessment criteria determined by the First Respondent.
2. The Applicant is to pay the costs of the application including any previously reserved costs.
